2.6.7. Acceptable Use – Terms & Conditions

Background:

Perth Seniors Fellowship owns valuable property and makes useful services available to members and the public. To preserve and maintain that property and those services and to protect Perth Seniors Fellowship and others from harm, rules governing acceptable use of the property and services must be established. Users must agree to the terms of this Policy before accessing and using the website, Wi-Fi, email accounts, and other property and services of Perth Seniors Fellowship.

Policy:

1. Introduction

These Terms & Conditions (“Terms”) govern the use of the websites, Wi-Fi networks, email accounts, and any other property or resources Perth Seniors Fellowship provides (“Services”). By accessing or using any of these Services, members, visitors and other users agree to comply with these Terms. Anyone who does not agree, must not use the Services.

2. General Acceptable Use

Services may only be used for lawful purposes and in a manner that does not infringe the rights of, restrict, or inhibit anyone else’s use and enjoyment. Prohibited activities include, but are not limited to:

- Engaging in illegal, fraudulent, or harmful activities.
 - Distributing malware, viruses, or other harmful code.

- Harassing, threatening, or abusing others contrary to the Harassment Policy.
- Accessing or attempting to access accounts, systems, or data without authorization.

3. Website Use

- Content on our website is for personal or authorized business use only.
- It is not permitted to copy, reproduce, or distribute our content without prior written consent.
- You must not attempt to disrupt or compromise the website's security or functionality.

4. Wi-Fi Network Use

- The Wi-Fi network is provided "as is" and may be monitored for security and compliance.
- It is not permitted to use the network to download, upload, or share unlawful material.
- It is not permitted to use the network to download, upload or share copyrighted material without the requisite licence or permission of the owner of the copyright.
- Bandwidth-heavy activities that disrupt service for others are prohibited.

5. Email Account Use

- Email accounts provided by Perth Seniors Fellowship are for authorized purposes only.
- It is not permitted to send spam, phishing emails, or any unsolicited bulk messages.
- Email account holders are responsible for safeguarding their login credentials and reporting any suspected compromise immediately.

6. Use of Other Property and Services

- Any physical or digital devices, storage media, software, etc. must be used responsibly and returned in good condition when required.

- Physical space and furniture must be returned to the condition they were in before use. Renters will comply with the Room Rentals Policy.
- Unauthorized modification, duplication, or resale of property or the abuse of Services is prohibited.

7. Privacy & Monitoring

We may monitor usage of our Services to ensure compliance with these Terms and applicable laws. Personal information will be handled in accordance with our Privacy Policy.

8. Duty to report

Any damage, however caused, any security vulnerability known or believed to exist or any violation of these Terms must be reported to staff immediately.

8. Breach of Terms

Violation of these Terms may result in suspension or termination of access, legal action, and/or recovery of damages. Members may have their membership suspended or terminated.

9. Changes to Terms

We reserve the right to update these Terms at any time. Continued use of our Services after changes are posted constitutes acceptance of the revised Terms.
